- On Memorial Day, Patty led us in a special Memorial Day prayer.
- At the UPW meeting on Thursday, May 7, there was some discussion about the fact that we are short on offering envelops this year, and some people who regularly attend do not have them. It was suggested that maybe we could put offering envelopes in the pews. We could either make them or purchase them.

• I have contacted paving companies regarding sealing and repairing our blacktop surfaces.

Parish Life, Sharon Havens, chair:

Mission & Stewardship, Jan Lafayette, chair:

- I have been promoting the Blessing Box, and trying to get assistance filling it. I discussed it twice in church. There is a short, 20-word ad in The Penny Saver until the end of July. It was in the WCDO community calendar, but I am not sure how long they ran it. Finally, I wrote a TriTown News article. I have been hearing that no one has seen it, so I just submitted it again and asked them to contact me with any issues. The UPW group decided that the proceeds for the summer breakfasts would be donated to obtain food for the Blessing Box. If it is more \$ than we need, some can go to help build the new Blessing Box.
- Dave Williams gave a Moment for Mission on June 3 about JAARS.
- The final amount of money collected for the Maji Solar Project was \$555. It is amazing to be part of such a caring congregation!
- The UPW would like us to hold a collection for Buckhorn Children and Family Services in Kentucky on June 24. Buckhorn is trying to refurbish their cottages and facilities. Kathy Williams will do a Moment for Mission on June 17 and June 24. The UPW has supported Buckhorn for many years.

- Approved start of summer services inside beginning in July. Communion will be served on 7/1, 8/5 and 9/2
- Approved request from Todd Straka and Tanya Burk to be married on Sept 29, 2018, 3 PM at the church. Sharon will send member's version of the use of church form to Todd.
- Discussed location for Operation Merry Christmas, since they will need to move out of the Presbytery Mission Center once it is sold. Made no commitment to use our old Sunday School rooms. Suggested that Operation Merry Christmas check with the village on use of the Grand St. building it purchased.
- Discussed Personnel Committee request for a small ramp in the sanctuary to help people navigate the tall step in the front. Decided upon a 4.5-inch step, about 3 ft. long with no railing.
- Dave mentioned that he had been contacted by a young man who needed a ride on Friday via Labors of Love. This individual has also asked for gas money, and Patty has helped him out.
- Discussed whether we wanted to provide offering envelopes in the pews for those who do not have them. Decided to table it for now unless we hear from others who do not have envelopes and would like this.
