- Loose offering of \$18.36 on June 24th collection plates was earmarked for the Buckhorn Children and Family Services in Kentucky. Kathy Williams presented a Moment for Mission on the project and the UPW will add enough to the offerings to total a \$500 donation.

- Approved benevolent gift of \$200 for the relative of a congregation member who has cancer.
- Approved that any loose money in collection plate through Labor Day be used for the UPW Buckhorn Children and Family Service's donation.
- Discussed using back rooms for Operation Merry Christmas, which needs to move out of the Presbytery building in Bainbridge. Since the group is likely to get a place at The Hospital in Sidney, decided to hold off on approval for now.

<u>Devotions:</u> 1 Corinthians 10:23-31 – Patty requested that we read it at our leisure. **New Business:** 

- Approved change to Session meeting schedule to the third Tuesday of each month at 6 PM with our next meeting on August 21.
- Discussed whether we are asking too much of people for mission. Decided the answer is no. Our church has a strong reputation of giving and ministering to people. We will continue to remind people that we should only give when we feel called to do so. Judy is going to check on the status of the Mt. Upton Food Bank.
- Discussed filling secretary position. General feeling is that position should be filled by someone outside or inside the church. A person outside the church would not know as much about announcements, prayer concerns, etc. Some concern about finding skills within church. Discussed a few potential candidates and preliminary next steps.

Our next meeting of the session will be Tuesday, August 21, 2018 at 6:00PM, at the church. With there being no further business, the meeting was adjourned with prayer by Jan Lafayette at approximately 7:40 PM.
